In the 1990s Dr. Jackson turned her attention to testing the impact of minority threat on crime control in different political and cultural contexts. She received a Fulbright for the summer, 2002, German Studies Seminar, "International Migration and National Identity," and she was later invited to collaborate, as a visiting fellow, with researchers at the Center for European Integration Studies in Bonn. Professor Jackson served on the editorial board of the *American Sociological Review* and is currently a reviewer for *Criminology*. Her 1991 article in *Justice Quarterly*, "Crime, Youth Gangs and Urban Transition: The Social Dislocations of Postindustrial Economic Development," has been reprinted in three edited collections, includ-

ing Ashgate Publishing's *International Library of Criminology, Criminal Justice and Penology*. In 1997 she received the American Society of Criminology's Mentor of the Year Award. Her research is closely related to her activities as a teacher in the areas of criminal justice, deviance, and social control. She was the 2000 recipient of the Paul Maixner Distinguished Teaching Award at Rhode Island College.
