Terence K. Hopkins Archival Material

Hopkins's archival boxes contain items that include course syllabi, outlines, and lecture notes for courses taught at Binghamton and Columbia. Drafts of research manuscripts and other essays written, including those for lectures delivered, are also included. The boxes also include Hopkins's resume, miscellaneous personal correspondence, grant proposals, and letters of recommendations written on behalf of others.
